**May peace and blessing of God be upon you**

**Good afternoon, good tidings.**

We have come to the end of the ninth CACJ meeting convened virtually in Jakarta.

It is an immense pleasure for me to find that we have successfully undertaken this ninth CACJ Meeting and all proposed Jakarta declarations have been unanimously agreed upon by the ASEAN judiciaries. This reflects the strong commitment and optimism of all ASEAN judiciaries to continue the judicial cooperation within the ASEAN region in order to establish prosperity, justice and security in the region.

We are all concerned that the pandemic still forces us to conduct the meeting without strong handshakes, without the warm discussion among friends, and without any other friendship-fostering activities that I believe play no small part towards maintaining judicial collaboration in ASEAN, and no single event has been conducted physically throughout 2021.

It is also a source of distress for me to see some ASEAN countries still struggling to overcome the pandemic with its ebbs and flows. I can only hope that the solution to our predicament can soon be found and we can all again pursue our ASEAN cooperation in the normal manner.

**Honorable Chief Justices,**

Please allow me to take this opportunity to once again express by highest appreciation and deepest gratitude to the Honorable Mulia Nguyen Hoa Binh, Chief Justice of the Supreme People's Court of Viet Nam, Chairperson of CACJ for the period of 2020-2021, whose leadership in the past one year has kept the gears of CACJ running smoothly and made sure that all its activities were able to be implemented despite the pandemic.

I would also like to convey my sincerest gratitude to the Chief Justices of ASEAN Supreme Courts, who have unfailingly rendered their support and cooperation to

CACJ's work, and who have been able to produce concrete results in all the working groups, despite the logistical difficulties that were faced, constituting a testament to the determination and resourcefulness of the ASEAN judiciaries in tackling this highly adverse situation.

**Honorable Chief Justices,**

My gratitude also goes out to all delegates of ASEAN judiciaries, representatives of working groups, liaison officers, focal points, local organizers, technical teams, interpreters, and those whose names I cannot mention on by one, for their tremendous work during the last few months to make sure that this event can be implemented as plan in a timely manner/ and to make sure that this meeting leaves a long-lasting impression on all of us, despite being organized in a virtual setting.

Lastly, but by no means less important, I extend my highest appreciation to the Supreme Court of Singapore, who for the last five years have undertaken the role of CACJ's Permanent Secretariat, mandate that it will again be assume for the next five years. I believe without reservation that the CACJ Secretariat plays a crucial role in holding together all the elements of this cooperation within CACJ and guaranteeing that members of the CACJ as an organization continue to be connected and able to work together effectively, rather than become a series of disconnected uncoordinated activities.

It is my belief that the CACJ Secretariat is an important investment for all of us as it offers support to any entity that assumes the chair of the council.

In closing, let us reflect on our gratitude to God the Almighty and pray that He will protect us all and allow us to meet once again next year without any failing.
